WELLS & PUMPS FOR IRRIGATION

We just did a major repair at the well pump at 75 Poole that had failed due to what we thought was a power surge of some sort. We had the well company doing the repairs inspect all of our equipment (3 wells) trying to be proactive and ward off any failures in the summer months that would stop water delivery to our landscapes. We discovered that there were some issues we need to address in not only the 75 Poole well pump, but the other two as well are in need of repair &/or replacement. While these repairs are not inexpensive, we must take care of these things immediately to prevent even more sod replacement in the future.

ENVERA GATE SYSTEMS WILL GO LIVE APRIL 9

The new Envera gate system is set to go live on Tuesday, April 9. All of the equipment is scheduled to be completed and tested by the end of Monday. Envera will be on-site on Tuesday to assist visitors & guests with the kiosks. Residents will continue to use the barcodes for access until further notice. Eventually there will be RFID's issued to all residents that will replace the bar-codes, but that is still off into the future. We will advise you of any updates as we get them.
