- Reading and Disposal of Unapproved Minutes —

- Treasurer's Report Jill Bartholmey reports that A/R is down \$1400. Otherwise, all is well.
- President's Report Cathy McCarthy reported on
 - new residents at 285 Tads, 90 Colette, and 60 Poole;
 - rust removal on Tads Trail walkways is progressing;
 - work orders have bee initiated for weed removal from mulched areas and removal of a dead palm at 40 Colette;
 - repair request initiated for a roof vent at 180 Tads

 - AWO has quoted \$325 to repair/replace carport numbers; materials are quoted at \$1500+
